In real time - a practical example of what this means.

Recently a dispute arose during one of our own South Kitsap School District Board of Directors meetings which pivoted on 1st Amendment rights. An attempt to make a case was made by the newest board director appointed to fill former board director Gattenby seat. Incredible as it may seem, this newly appointed director stated that board directors should not be writing letters to the editors of our local newspapers. To many this may sound like an extreme view that would be dictated by some Banana Republic dictatorship. This was not the first salvo from the current school board against one of their own board directors during the public meeting held on February 16, 2022.

Here is a video snip of the exchange provided by this board director at the board meeting which challenges our 1st Amendment right of free speech, which in this case is any board director's right to send letters to newspaper editors: https://youtu.be/bPuAn5Wts18 Incredible as it may seem, this director that was appointed by the majority of the school board doesn't yet quite grasp this practical application of our First Amendment Rights.

School Board policy problems.

The premise is sound that one director should not speak for the entire school board if the full board has not previously voted and agreed. In fact this is a standing school board policy. Whereas writing letters to the editors as a private citizen is everyone ones right, including any private person to include any elected official. To sign otherwise as a board member would certainly give the public the perception that the letter writer is speaking for the entire school district board of directors. And this indeed discussed in board polices. This was the issue that the board chair raised. Problem is the board chair jumped to conclusion, apparently acting out in a retaliatory manner by his efforts to try to 'dress down" a fellow board member. What we clearly witnessed (if you watched the board meeting) was lesson hypocrisy. At issue before this 'dressing down' effort by the board chair was how the board chair signed for the board on a joint letter published just two days after the board's Town Hall community zoom meeting. Not all of the school board members saw this letter until after its hasty publication on the SKSD Website and Face Book pages two days after the Town Hall that was held on January 26, 2022. The title of the statement is South Kitsap schools Joint Statement of Civility and Respect dated January 28, 2022. It is a good letter, a fine letter in fact but some felt it was a letter written to shame the community due to some behaviors during the Town Hall held on Zoom a few days before. The relevant problem here is also the fact that a school board director addressing himself as school board chair signed on with the rest listed on this letter. Fact is that the school board never reviewed or agreed much less voted to have the board chair sign for the board on this apparently co-sponsored letter. School board policy was clearly violated. The same thing that the board's chair accused a fellow board director of who actually submitted his letter to the editor as a private person/citizen and not speaking for the board.

As far as the claim made by the current board chair that the letter writing board director has extreme views, this is entirely different attack and insult by the board chair. Regarding public participation at school board meetings.

The majority of this school board also doesn't seem to understand that the laws of our State do not permit this school board to condition who can speak and for the most part what they can say about others including board members, school staff, school administration. These same State laws also mandate that the school board cannot require those who wish to give public comment supply their names, where they live, what they wish to make public comments on. These prohibitations cannot be imposed nor can they be enforced. This law clearly spelled out in the Revised Code of Washington. RCW <u>42.30.040</u>. Conditions to attendance not to be required.

A member of the public shall not be required, as a condition to attendance at a meeting of a governing body, to register his or her name and other information, to complete a questionnaire, or otherwise to fulfill any condition precedent to his or her attendance.

Lastly a few more things that were discussed at the school board meeting held on February 16, 2022. Also a link to the first ever SKSD Board Virtual Town Hall held on January 26, 2022.

Regarding the Aspen Group.

The advisements given by a contractor named The Aspen Group who were paid in excess of \$65,000 for their services is still advising the board for one more year. This is the same group and contract that still had a year to go but the new board chair wanted to 'scrap them' and move on since things had been moving to slow on the board's efforts to re-write policies and governance rules. That is until he was told the money on the remaining services for the next year would not be refunded.

Issues brought forth by the Aspen Group that were finally fully acknowledged by new board members were that the school board of directors must not be in charge of any standing committees. (Long Range Facility Planning Committee, Educational Materials Committee, etc.) It is supposed to be the school superintendent that manages long term standing committees.

Another important take away from Aspen Group advisement is that the school board must add in their polices that the board of directors also be identified as the audit board for the board. To date, for the past two plus years it has only been on board director who has been reviewing warrants (bills being approved to be paid by the board during consent agenda). This means the board continues to be violating their own polices as well as state law. The entire board (Established as the Audit Committee for the board) are required review the details on warrants (bills) the costs that are being paid and approved by the board.

The board is now voting without full review of and approving payments of these bills for services and purchases that are much higher than any of can imagine. The board continues to approve these expenditures through the process of voting to approve them in consent agenda portion of the board meetings. Cleary they have no clue as to what the are approving and they can be individually held legally accountable for these failings.

The Aspen Group also advised that the entire board take part in determining the agendas for meetings, not just one or two board members and the superintendent as has been the practice of many past boards.
