Thank you so much for reviewing and granting my AH order against Mr. Kimble. I was relieved when he was served and he took down the last "hit piece" on me from his web-site only to be dismayed to see it go back up the very next day (on or about May 1). *This document "Ethics and Candor" is filled with malicious untruths about is designed to provoke and attack on my and/or my family by admitted fraudster, MAGA agitator, and 2nd Amendment extremist Justin Daniels (or one of his acolytes).*

Mr. Kimble knows that I worked with Gerry Austin gather evidence (per the statute) to expose Mr. Daniels Election fraud and other crimes and have him successfully disqualified from the 2021 election. So Kimble knows that Daniels (and his followers) have a grudge against me for exposing their crimes. This is the same Justin Daniels who threatened Gerry Austin face-to-face while leaving the hearing room and later who threatened me in a school board meeting over zoom during public comment while holding his assault rifle on camera. I do recall meeting with Mr. Wilson in my office in late 2021 or early 2022. I have no notes of that conversation, *but I recall it was about my decision to not charge Mr. Daniels with a crime related to his conduct in the 2021 school board election. I would need to see Mr. Wilson's declaration to determine the veracity of his statements. However, Mr. Daniels is not a "three strike" offender under the Washington State persistent offender law.*

I'm happy to discuss this with your counsel. However, I have very little recollection of the conversation with Mr. Wilson.
