This is a follow-up letter to the one I sent to Judge Seaman on Friday. Since being served his AH-Order, Mr. Kimble has been busy trying to cover his tracks and obfuscate the truth. He has already broken the KC courts order by engaging a 3rd Party (Jeffrey T. Daily) to continue his harassment (RCW 9A.90.120) campaign on his CSSKSD web-site (which now claims to be "managed and maintained by Jeff Daily." I would wager that the CSSKSD is still very much OWNED by Mr. Kimble...but now, as always, he's pointing the finger at Mr. Daily. This weekend, Daily (in Kimble's stead) has republished the bulk of the defamatory, threatening, and harassing documents (their greatest hit pieces if you will) that HAD been taken down in haste by Kimble when he tracked me to the courthouse and learned that I was serious about filing a set of AH orders against Kimble (and Daily). In addition, the court documents posted on their CSSKSD web site now list my EXACT ADDRESS and the repeated invitation to find my wife (at her place of work) and my children (at their SK Schools). Not to mention the hate crime in saying that my "transsexual" son probably needs protection from Bullying (indeed he does from Mr. Kimble and Mr. Daily) and so do I.

In light of this recent development, I humbly request that you reopen my AH Petition against Mr. Daily (24UH00354) or at the very least get him under oath at Mr. Kimble's hearing so we can get to the bottom of Mr. Kimble outsourcing his dirty work to Daily. Mr. Daily has now reposted the bulk of the very same materials contained in Mr. Kimble's AH order (and in my original petition on Daily). These two have been fooling the PDC and the press with these antics for years and now they think they can pull the wool over the eyes of the KC courts. Please don't let this well-coordinated harassment campaign by Mr. Kimble (and now Daily) continue; it has been three years of escalating threats from these lunatics.

Additionally, the prima facie evidence does not list a specific incident and approximate date of occurrence that would support an anti-stalking, domestic violence, sexual assault or other protection order as defined in RCW 9A.04.010.
 - Other Findings:**
- ORDER(S):** The Court orders that:
 - Petition Denied:** For the reasons discussed in section A of the Findings, the Court denies the prima facie allegations that could support the issuance of any type of protection order this Court has authority to issue. Therefore, the Petitioner's Order is denied pursuant to RCW 9A.04.010.
 - Amended Petition Permitted:** Petitioner may file an amended petition within 14 days of this date of this Order. If an amended petition is filed, the Court will thereafter determine whether the amended petition contains prima facie allegations that support the issuance of any type of protection order this Court has authority to issue (p.c. RCW 9A.04.010).

5. **NO COURT DATES SCHEDULED:** Neither a hearing nor a trial is scheduled for this case.

6. **CLERK'S ACTION:** The Court will provide a copy of this Order to the Clerk.

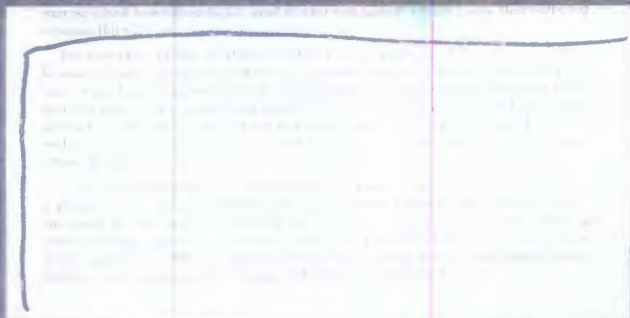
