Well of course the National Education Association would say teachers are underpaid. NEA (and all education unions) thrive and live for as many pay increases that they can 'broker', which always equates to increased union membership, which in turn keeps the unions 'goring' on our tax dollars. Notable that our state now ranks #4 in all of the U.S.

Here is how our state stacks up:

The <u>Census ACS</u> 1-year survey reports that **the median household income for the Kitsap County** Washington area was \$79,624 in 2019, the latest figures available. Kitsap County median household income is \$937 higher than the <u>median Washington household income</u> and \$13,912 greater than the <u>US median household income</u>. 2020 county income data (including Kitsap County median household income) will be released in September of 2021. <u>Median family</u> and <u>per capita income</u> for Kitsap County are shown below.




Median Household Income by State 2021

8. Washington

Washington's median household income is \$76,687, the eighth-highest. Washington is the country's seventh-most educated state, with 13.7% of adults having a graduate degree or professional degree. Seattle contributes to Washington's relatively high median household income. About half of the households bring six figures home, and the median household income is \$102,486, the third-highest among the nation's largest cities. South Kitsap ranks #2 statewide in average median income of \$75.5K with only King County being higher in our state.

The average individual income in America in 2021 was \$63,214.03. As I mentioned in the household income section, median is a better measure – high earners skew the average. The average individual income would be roughly the 67th percentile of individual incomes.

And what about South Kitsap School District's Annual Budget.

SKSD total budget is approx. \$160 M. There are many moving parts in this budget, and many competing needs/wants/ and requirements.

SKSD Funding Sources

School Emergency Relief Funds (ESSER Funds) currently make up \$20M of the budget.

The State kicks in another \$127M.

Federal funds account for another \$5M.

Unidentified 'other sources' reported to be \$3M.

The SKSD payroll alone is now up to \$143M. The math is easy here, after paying all of the employees the entire State funding is exhausted. That leaves the district with only \$8M. These are levy funds. now used to run the rest of the school budgets. And how did the district get here? It is said that the district might be only two levy failures away from the State taking over. It nearly happened before.

One of the strongest "sucking sounds" is the continuing annual across the board pay raises which are mandatory due to fancy and non transparent "negotiations" for the three unions running the district. That is at a minimum a 3% pay increases across the board annually. That doesn't include the annual cola increases. These incurred costs are made worse by the fact that SKSD hired and still employees 200 more employees than the State authorizes/pays for. Many of these employees were hired when the court settlement funds from the McCleary lawsuit settled and schools got their share of that pie. At that time, the Office of the Superintendent of Pubic Education (OSPI) gave clear warnings to all of the 295 school district in the state that the McCleary funds were a one time flood of cash.



OSPI cautioned all district to hire and budget according. Not to expect more of those types of dollars being available again. Districts were essential told to stay within the funding amounts that OSPI distributes annually. OSPI 'strongly advised' districts not to hire above the number of employees that OSPI provides funding for. Most district followed OSPI advisement. SKSD currently employees, whereas the OSPI only authorizes 1200. With these big budget issues at play, the self inflicted budget shortages, there is now talk of possible reduction in force (RIF) notices coming out in May. It was just a matter of time. The district now relies on ESSER funds to try and plug holes, patch some of the budget 'leaks'.




Here is the breakdown of how many employees in each title that are authorized an funded by the State (OSPI) and how many SKSD decided to employ.

Making matters even more financially 'challenging, T he district has had continued declines in student enrollment since COVID began. Currently there are 700 less students and enrollment and no sign of them coming back. The Chief Financial Officer of the school district states each student is worth \$1200 in State funding, The district is down 700 student. The approximate loss of funding due to decline in student enrollment is now at \$8.4M of State funding.

So where does the extra dough go? Well one example would be the original estimate to 'refurbish' SKSD community pool. That started at an estimate of only \$3M and is now broaching beyond \$12M. Currently that project is on 'hard hold'. And there are other stark examples of "Where Our Tax Dollars Go"
