- J. Berg portrays his private website as a tool to help educate and indoctrinate the new candidates who will be running for school board director seats. Reading his posts, you will find no educational tools, links, or other intrinsic value to school board candidates. In fact, none of his posts or mutterings contains any of the customary and typical information or guidance associated with campaign-oriented organizations.
- J. Berg's website has nothing on it that resembles an effort to help candidates running for office. Nothing similar to real organizations like the League of Woman Voters, Kitsap County Elections Division, Kitsap County Republican Voters, Kitsap County Democratic Voters, or Kitsap County Libertarian Voters.
- Review the video clip where of the board meeting where board vice pres. J. Berg brings a motion to dismiss, then votes to dismiss all charges brought against by Director Daily.
- The same video clip of the same board meetings J. Berg inappropriately promotes his private website, yet while wearing his board director hat and badge, he makes the claims that his private website is not related to school board business while shamelessly and ceremoniously promoting this website during an official school board meeting (*see the video clip).
- The link to J. Berg's private website makes claims that his private website is designed to educate and inform the public as well as the current school board candidates running in this election cycle. J. Berg's 70-page rant on his private

website does nothing to help the 10 school board candidates other than exposing the mess that J. Berg has now created.

- **J. Berg practices antiquated and unconventional parliamentary rules including Roberts Rules, rules of meeting conduct that were never adopted by a required school board resolution. He distorts the true purpose of using Roberts Rules in efforts to shield him from the consequences of the dubious actions he is undertaking now as a form and method to retaliate against a fellow board member. This is what the candidates for school board positions will see when and if they visit his private website.**
- **J. Berg tramples upon our State's Statues and Revised codes established and adopted for all school boards decades ago. His actions raise serious and legitimate concerns regarding his fitness to serve as SKSD Board of Directors Vice President, as well as remaining seated on school board as a director.**
