someway affiliated with CitizensSupportingSouthKitsapSchool District (fronted by Kimble) and/or the South Kitsap Citizens Supporting Responsible Taxation (fronted by Daily). Mr. Pickard and I both both backed a new BOND Measure in our 2021 School Board Director campaigns and also personally shepherded the SK BOND through more than a dozen public meetings (in 2022/2023) and along with many, many formal school board meetings (2021 thru 2023) where Brian and I have both shown our unwavering support for the SK Bond effort. Both Mr. Kimble and Mr. Daily were present at many of these meetings, they both clearly understood our support for the BOND and nonetheless MALICIOUSLY created these doctored images of us to spread their lies, damage our reputations, and I suspect hope to reduce the chances of the SK BOND passing in the Fall. Brian and I would like to see both Mr. Kimble and Mr. Daily criminally prosecuted to the fullest extent of the law for committing liable against us both. File a Formal Complaint - Jeffrey Wilson

David A. Kimble and Jeffrey T. Daily have committed libel by publishing doctored photos of South Kitsap School Board Directors (Wilson & Pickard) holding anti-BOND messaging, severely damaging their reputations as SK Directors and implying that they are in any way affiliated with CSSKSD and/or SKCDRT which both oppose the upcoming school BOND.

In addition, Daily appears to have placed (unregistered) signs against the other SK School Board Members (circa February 2023) thereby interfering in the 2023 election campaigns of John Berg and Kate Espy and potentially the 2025 campaigns of Jefé Wilson and Brian Pickard should they choose to run again in 2025.
